We work with the media on the importance of cancer prevention. The Foundation produces materials to educate the public on cancer prevention. The Foundation's Guide to Preventable Cancer outlines the nine cancers the Foundation focuses on, including symptoms of the cancer, risk factors, ways to reduce risk, screening methods and viruses and cancer.
